#### PENAL NOTICE

#### **Notice to the Defendants**

You should read the terms of this Order very carefully. You are advised to consult a solicitor. This Order prohibits you from doing the acts set out in paragraph 11(a) (and Schedule A) below and obliges you to do the acts set out at paragraphs 11(b) and 11(c) (and Schedule B). You have the right to ask the court to vary or discharge this Order.

#### **UPON HEARING** the Trial of this matter on 30 and 31 October 2025

**AND UPON** the Court having handed down judgment on 20 November 2025 using the neutral citation [2025] EWHC 3063 (KB) ("the Trial Judgment")

#### IT IS HEREBY ORDERED THAT

- 1. Judgment shall be entered for the Claimant in his claim for libel.
- 2. The Defendants will pay the Claimant the sum of £70,000 by way of damages, such damages to be paid by 4pm on 16 December 2025.
- 3. The Defendants will pay the Claimant the additional sum of £7,000, being 10% of the damages award of £70,000, in accordance with CPR r.36.17(4)(d), by 4pm on 16 December 2025.
- 4. The Defendants will pay the Claimant the additional sum of £13,339.48 in interest on the damages sum at (2) in accordance with CPR r.36.17(4)(a), by 4pm on 16 December 2025.
- 5. The Defendants' counterclaim for harassment is dismissed.
- 6. The Defendants will pay the Claimant's costs of his claim and of the counterclaim.
- 7. The Defendants will pay the costs referred to in paragraph 6, above, in accordance with CPR r.36.17(4)(b), as follows:
  - a. in respect of costs up to 5 July 2024, on the standard basis; and
  - b. in respect of costs since 6 July 2024, on the indemnity basis.
- 8. The Defendants will pay interest on the costs referred to in paragraph 7(b), above, in accordance with CPR r.36.17(4)(c), in the sum of £11,746.88.
- 9. The costs and interest referred to in paragraphs 6, 7, and 8 above will be the subject of detailed assessment if not agreed between the parties.
- 10. The Defendants will pay the Claimant a reasonable sum on account of his costs and the interest referred to in paragraph 6 and 8, above, to be paid by 4pm on 23 December 2025. Such sum shall be determined by the Court by way of written submissions if not agreed,

with the parties to lodge written submissions by email if there is no agreement by 4pm on 9 December 2025.

#### 11. The Defendants and each of them are:

- a. prohibited, by any means howsoever, from publishing any further words that bear the same or similar meanings to those set out in Schedule A to this Order;
- b. shall remove the webpages identified at Schedule B to this Order by 4pm on 16 December 2025; and
- c. shall remove any webpages that either of them have published on any website including but not limited to Techrights, Tuxmachines, and www.schestowitz.com, that contain the same or similar meanings to those set out in Schedule A to this Order.
- 12. The parties will seek to agree a summary of the Trial Judgment pursuant to section 12 of the Defamation Act 2013 and the time, manner, form and place of its publication by 4pm on 9 December 2025. If there is no agreement, the parties will provide an explanation by the same deadline as to why no agreement has been reached, following which the Court will provide further directions.
- 13. The Second Defendant's application for permission to appeal is refused.
- 14. The Claimant has liberty to apply to the Court for an order under section 13 of the Defamation Act 2013 under this paragraph without commencing fresh proceedings.

#### INTERPRETATION OF PARAGRAPH 11 OF THIS ORDER

A Defendant who is an individual who is ordered not to do something must not do it himself/herself or in any other way. He/she must not do it through others acting on his/her behalf or on his/her instructions or with his/her encouragement.

  - (ii) This campaign includes many examples of material that is illegal (including examples relating to hate crimes, drugs or violence) or offensive (including examples which are misogynistic, racist or paedophiliac).
- (7) (i) The Claimant is responsible, including by operating multiple sockpuppet accounts, for an online campaign of threats, abuse and harassment.
